6. PLANNING APPLICATIONS

a. To consider New Planning Applications

13/07145/FUL: Mill Lea Pink Road Lacey Green Buckinghamshire HP27 0PG

Proposal: Householder application for replacement of flat garage roof with pitched roof and insertion of a window in front gable. **The Parish Council has no objection to this application.**

13/07174/TPO: 5 Hambye Close Lacey Green Buckinghamshire HP27 0QZ

Proposal: Fell Twin-stemmed Ash.

The Parish Council will abide by the decision of the Aboriculturalist.

13/07350/AGI: Grazing Land Behind Collins Farm Lower Road Loosley Row

Proposal: Agricultural Notification of erection of open hay barn/tractor store/feed store

The Parish Council has no objection in principle to agricultural buildings. However, in this case, the Parish Council found it difficult to comment owing to the fact the Application fails to record the materials to be used in construction of same.

It was felt this was important as the site is close to the Loosley Row Conservation Area boundary. The Application also states the site cannot be seen from a public road, public footpath, bridleway or other public land. In fact, a public footpath passes immediately by the proposed site.

13/07281/FUL: Speen Farm Lodge Slad Lane Speen

Proposal: Householder application for erection of single storey side extension with rooms in roof space and Juliet balcony to first floor side and alterations.

The Parish Council has the following comments:-The site lies outside the curtilage of the village within the Green Belt and Chilterns AONB. Provided the proposal meets the requirements of Policy GB6 of the Local Plan, the Parish Council has no objection.

13/07358/FUL: The Haven Main Road Lacey Green

Proposal: Householder application for construction of part two storey, part single storey side/rear extension and first floor side extension. Construction of one dormer window to front and reconstruction of one existing dormer to rear, associated rooflights (five), new porch to front and erection of detached double garage to front.

The Parish Council has the following comments - The proposed extension will create a dwelling of substantial size. The Parish Council has a concern regarding the proposed detached double garage. It would have a detrimental visual impact on the front garden and the street scene. The Chilterns Buildings Design Guide (3.79) suggests front gardens should not be turned into parking areas, nor garages set forward of the main building. Furthermore, to avoid creating parking areas which dominate the front of the building in full view of the street.

Proposal: Householder application for construction of construction of first floor extension and new pitched roof to detached garage. **The Parish Council has no objection to this application.**
