1. APOLOGIES FOR ABSENCE

Apologies were received and accepted from Cllr T Molesworth

2. MINUTES

The Minutes of the previous meeting of the Parish Council meeting on the 4th March 2013, having been circulated were approved by the Meeting and signed by the Chairman.

3. DECLARATIONS OF INTEREST

Members were asked to declare any personal interest and the nature of that interest which they may have in any of the items under consideration at this meeting. None were declared.

4. MATTERS ARISING NOT OTHERWISE ON THE AGENDA FOR INFORMATION ONLY

Cllr M Hughes gave an update on matters relating to Miss Lacey Green. She is returning to the village with a film crew in August and is seeking accommodation for one night. Cllr M Hughes offered to investigate possible places. Cllr C Davies suggested a building at Grymsdyke Farm, owned by an artist, which has dormitories. Cllr M Hughes has alerted Rebecca Cain at the Bucks Free Press to the visit. **MH**

5. A REPORT ON DISTRICT COUNCIL MATTERS FROM WYCOMBE DISTRICT COUNCILLOR M FOSTER

Apologies were received from WDC Cllr Mel Foster. Cllr C Davies delivered the report on council matters from WDC. Cllr D Claydon requested that Cllr M Foster be asked to take up the issue of recycling collections, as a smaller lorry now serves properties from White House Farm into Speen. Using the large lorry to go there is no longer necessary with its attendant dangers to walkers and wildlife. **SG**

a. To consider New Planning Applications

13/05505/VCDN Green Acres, Lower Road, Loosley Row, Buckinghamshire, HP27 0PF

Proposal: Variation of condition 4 (non-reflective glazing in rear elevation) of planning permission 09/05781/FUL for the raising of roof and construction of front, rear and side extensions to allow the use of soft e glazing in rear elevation extensions.

The Parish Council has no objection to this application.

Proposal: Certificate of proposed lawfulness for single storey rear extension.

Proposal: Change of use of barn to form toilets, showers, changing area and treatment room to be used in connection with the existing gym (retrospective)

The Parish Council has no objection to this application.

13/05543/FUL: 13 Roundlands Lacey Green Buckinghamshire HP27 0QL

Proposal: Householder application for construction of two storey front and side extension and new porch
The Parish Council has no objection to this application.

13/05651/FUL: Highways, Pink Road, Lacey Green, Buckinghamshire, HP27 0PG

Proposal: Householder application for construction of single storey rear extension, internal and external alterations to existing dwelling and construction of new detached garage/garden store. Siting of temporary mobile home during construction work.

The Parish Council has no objection to this application.

13/05673/CTREE: Applegate Cottage, Studridge Lane, Speen, Buckinghamshire HP27 0SA

Proposal: Fell Ash to rear of the property.

The Parish Council would prefer to see the crown thinned rather than the tree felled, but will abide by the decision of the District Arboriculturalist.

13/05749/CTREE: Grace Cottage, Church Lane, Lacey Green, Buckinghamshire HP27 0QX

Proposal: Fell 1 no Yew (T1)

The Parish Council is a little alarmed that this is the second application to fell a tree in 6 months and would like the District Arboriculturalist to consider alternatives.

Letter from WDC re Wycombe District Local Plan 'Community Conservations' dated 03.03.2013

Cllr J Sherlock explained that the proposal by WDC Planning Department is to get all the Parish Councils within a certain area to get together to discuss the Local Plan. Cllr C Davies expressed the opinion that this is a duplication of effort as all the Councils mentioned in the letter are already members of the North West Chilterns Area Forum. She proposed replying to Mr Pantel suggesting that a 15 minute slot could be found for the 'Community Conversations' at meetings of the NWCAF. A letter should also be sent to the NWCAF asking if they would be willing to allow this. **All present agreed.** **SG**

9. REPORTS ON ROADS, VERGES AND RIGHTS OF WAY IN THE PARISH

Cllr D Claydon requested that the Clerk report to BCC that ivy and weeds are growing under the pavement of the footpath outside St John's Church in Church Lane, Lacey Green. **SG**

10. AN UPDATE ON THE GARDEN OF REST

Cllr D Claydon reported that Cllr J Sherlock had turned the water back on. Nothing else to report.

11. THE ACTION TO BE TAKEN CONCERNING THE NOTICE BOARD IN SPEEN AND THE SPEEN BUS SHELTERS.

Cllr R Craft reported that due to the recent very cold weather he has not yet had a meeting with the contractor, but will do so before the next meeting. **RC**

12. ACTION TO BE TAKEN ON THE MAINTENANCE OF THE NOTICEBOARD IN WESTLANDS ROAD

Cllr D Claydon will give the key to Cllr C Davies, who will then give it to the contractor. **DC/CD**

13. THE PREFERRED CONTRACTORS FOR THE MAINTENANCE CONTRACT

All present agreed to appoint the Princes Risborough Town Council Maintenance team as the preferred contractors for the maintenance contract for 2013. Cllr R Craft proposed signing the standing order for this and **all present agreed**.

14. WHETHER TO PROVIDE A LOAN FOR SPEEN VILLAGE HALL

Cllr D Clay presented a list of trustees of Speen Village Hall, together with 2 years' audited accounts to 2012. He explained the reasons for the loan and stressed that it would be repaid within 1 year. He assured the meeting that the Treasurer of the Village Hall will set up a Direct Debit or Standing Order for future bill payments so that the problem cannot arise again. Cllr C Davies proposed granting the loan, and accepting the terms of repayment subject to the agreement of the RFO. Cllr M Hughes seconded. A vote was taken and **the motion was carried** unanimously. **SG**

15. REPORTS FROM COUNCILLORS ON MEETINGS THAT THEY HAVE ATTENDED.

Reports were received from the members on the meetings that they had attended on behalf of the Council. Cllr J Sherlock reported that at the meeting of WDALC a 25 year service certificate was awarded to Cllr D Claydon. Cllr C Davies reported that she had attended the meeting of the NW Chilterns Area Forum. County Cllr Richard Pushman is standing down. A quotation had been obtained to open up the footpath between Culverton Crossroads and the Upper Icknield Way: the cost quoted is £ 46,000.00. This proposal has been rejected and an alternative quotation will be obtained. Cllr D Claydon had a meeting with the Local Area Technician. They will meet again in May and will discuss the trees in Wardrobes Lane.

To discuss and decide on progressing the application for gas supply to Speen.
