Remedial works have been provided to Flowers Bottom Lane
The Bledlow Ridge CIC project now has the support of 14 Councils and is currently seeking a consultant to apply for planning permission

The District Local Plan has been approved and adopted

As discussed in Cllr Etholen's report, it was noted Cllr Davies had tabled a tighter specification for the project with the addition of traffic calming measures on the corners of Kiln Lane/Main Road, the outward blind corner between the school and Slad Lane, the corners on Slad Lane/Main Road and an extension of the National Speed Limit zone.

The traffic report circulated by Cllr MacGillivray was also discussed in detail and the Council agreed to publish the key findings in Hallmark and share with County Councillor. The Council also noted that thanks should be extended to the MVAS volunteers
