1. WELCOME AND APOLOGIES FOR ABSENCE.

3. MINUTES OF PREVIOUS MEETINGS

5. REPORT FROM COUNCILLOR ETHOLEN

The matter relating to the proposed closure for footpath 40 was discussed in some detail and Cllr Etholen **agreed** to progress matter, as well as the application for the footpath registration relating to Wood Road and Foundry Lane

Traffic calming measures for Wardrobes/Woodway were also discussed for more detailed consideration at subsequent meetings

6. INSURANCE RENEWAL

Revised quotation circulated to Council members and **approved** for 3 years

Cllr MacGillivray confirmed that the MVAS is now functioning correctly following visit from the Swarco engineer. The analysis of the data output is still outstanding.

9. STUDRIGE LANE POND

It was noted that the project team associated with clearance of the pond (SEAG) had requested the provision of a noticeboard, bench and duck platform (already installed). It was **agreed** to inform the project team that the Council would review the suggestions, but that **no** further work should be undertaken without approval from Council

11. ANCHORAGE OF PLAYGROUND BENCH

It was **agreed** to proceed with the purchase of the anchor kit and a quote for installation

13. BLACK HORSE COMMUNITY RIGHT TO BID

Cllr Roberts confirmed that the nomination will be submitted to the Unitary Council Panel for registration on 18th February and the procedure for right to bid then invoked **JR**

It was noted that since June, 2 thefts, 3 assaults, and 2 dangerous dog incidents had been reported.

Following discussions with Cllr Etholen, it was agreed that the Clerk would provide the historic email trail from September 2019 onwards, relating to the request to close footpath 40, in the context of the parallel location of footpath 39 and the very infrequent use of footpath 40
