1. WELCOME AND APOLOGIES FOR ABSENCE

The outcome of the Hedgerow application at the Appeals Committee was also discussed, noting the application was approved.

The draft nomination form for the King William IV had been circulated and **approved** in principle, subject to further editorial enhancements.

Latest proposals by members of SEAG were reviewed and discussed in detail. Although the Council, following advice from its own experts, had no fundamental objections to the proposals and associated costs, it requested that BBOWT and/or Chalk, Cherries & Chairs Landscape Partnership Scheme attend a meeting of the Parish Council to discuss the matter further.

The Council needs to be reassured that the plans are sufficiently incremental, so that no changes are initiated which could fundamentally affect the nature of the pond.
